## DECLARATION OF CONFORMITY TO THE Regulation (EC) 1907/2006 (REACH)

With reference to the European Regulation concerning the registration, evaluation, authorization and restriction of chemical substances (REACH), Sirio Antenne Srl is configured as a downstream user of these chemicals.

The products manufactured and sold by Sirio Antenne Srl are configured, by definition, as articles with no intentional release of substances and, therefore, the company is not subjected to the registration obligations referred to in Article 7 of the regulation covered by the aforementioned declaration.

As producer of articles that may contain SVHC included in the Candidate List, that can be verified on the updated list at the following address <https://echa.europa.eu/it/candidate-list-table>, the company is required to communicate to its customers the presence of these substances in the event that they are present in concentrations higher than 0.1% w / w.

Based on the knowledge obtained from the supply chain and in accordance with Article 33 of the REACH regulation, the company inform that its products contain Lead (CAS 7439-92-1) in some components with a content > 0.1% w / w.
